Meeting called to order: 10:05 AM

Introductions: Welcome to new member Bill Croft and our guests Bruce Odell and Joyce Strawhand.

Responsibilities of board members has grown over the years because the lake requires more care now due to changing weather patterns, floods, global warming, weeds, etc. LWLA is recognized as innovators. We were the first in state to incorporate chemical treatment. Today DEC gives us 5 year permits due to our track record and their trust in what we are doing. To ensure continuation of the health of both lakes it is important members continue to be proactive and provide new ideas.

Please note the October BOD meeting will be October 10 instead of the 17th. This is due to the conflict with the NYSFOLA western region meeting.

We have had some sad news with a few deaths. A sympathy card was sent to Whitney family who had accident with cannon on Lamoka Lake. We also lost Jim Frawley a past board member known for humor and wit, Malcom Hayes 90 years old from Lamoka Lake and Ray Ruff past board member and Librarian. They will all be missed.

OLD BUSINESS:

Minutes from August 15th BOD Meeting and August 29th Public Meeting were approved unanimously as written.

Treasurer's Report: Kurt supplied a printed report with the following highlights:

Checking \$14990.25 + \$3,600 (from flares to be deposited) = \$18,663.25

Savings \$20,174.83

Fixed assets \$ 7,363.58 (Furniture and equipment)

Total (about) \$45,000.00

→ Kurt will send treasures report for October meeting to Terry to present since he will not be at meeting

Kurt printed/stuffed membership dues letters and envelops. They are ready to be sent out in January

NEW BUSINESS:

Lake District Commission meeting Sept 12, 2015 highlights -

Permitting Requirements

- 1. We have a permit for treatment good until 2019. Permit for current treatment only if change need new permit
- 2. An annual plan must be submitted by Feb. 1, 2016

- 3. Must include Bob Johnson's plant report
- 4. Riparian announcement must be made
- 5. Notification to DEC 7 days prior to treatment
- **6.** Before Apr. 1, 2016 fees payments to DEC
- 7. Dec. 1 submit this year's report to DEC

Finances:

- 1. <u>In treasury at this time</u> Steuben County -\$0 Schuyler County \$1,000
- 2. We collect \$102,000 annually fees to be paid: \$11,000 for plant studies, \$15,000 waste water management & unknown cost of Chemical treatment based on needs of both lakes
- 3. This year's costs \$160,000 = \$104,000 Waneta treatment + \$51,000 Lamoka treatment + \$5,000 misc. fees

Waneta <u>and Lamoka Differences</u>:

- Clarity on Lamoka very good more plants and algae growth
 Discussion at BOD meeting Report of EWM on Lamoka Lake Only Sparse area on east side
 near Baptist Camp. Losing battle with EWM on Lamoka –Flood dissipated Renovate before it
 could do complete job.
- 2. Turbidity on Waneta high –fewer plant growth little to no algae
- 3. Southern Naiad prevalent to Lamoka and there is now a mud layer since the flood. Plant species have increase in Lamoka ring around the lake.
- 4. Lamoka 35 points of Eurasian milfoil, the Channel 8 points, Mill Pond 40 points
- 5. Waneta 2 points at north end
- 6. A few milfoil locations in Channel near Lamoka side

Projects Costs for 2016:

- 1. \$113,300 = \$97,500 (for Lamoka Lake 75 acres) + \$15,800 (for Channel)
- 2. After paying for plant and wastewater management, there will be \$76,000 left for treatment
- 3. There will be a shortfall in financing of approximately \$40,000

How can we make up this financial shortfall?

- 1. Ask for membership donations
- 2. Revenue increase
- 3. Change in testing look for milfoil and hydrilla only
- 4. Change in liquid or granular for certain areas.

Questions and Answers asked to Schuyler Legislature

- 1. Can we increase District scale of charge without voter approval? Probably not. Would need Public referendum. It is unclear if there are any tax cap implications with an increase in charges.
- 2. Can District solicit donations from Taxpayers? Yes
- **3.** Can the District solicit donations to the LWLA? Yes. The District probably should sign a simple Memorandum of Understanding with the LWLA indication that such donations will be used solely for the treatment of invasive species.
- **4.** Can the District receive funding from the LWLA? Yes

Summary: Based on above think #2 is too administratively burdensome for the county to handle. Would prefer a combination of #3 and #4 in which LWLA would jointly send out an appeal letter (similar to joint Riparian notification letters) requesting donations be sent to the LWLA. And then at some appropriate time LWLA will submit a check to the District for supplemental treatment of Lamoka Lake.

Discussion by Board Members:

Why should Waneta pay for Lamoka?: Preventative – Water comes into Waneta from Lamoka and there is no inspection of boats as they travel between lakes.

How to close shortfall of cash required for treatment?

- 1. Is it possible to decrease cost of Plant Study by polling less plants?
 - **→** Is someone doing this
- 2. How much can LWLA donate to district for shortfall?
 - → Sean see how much LWLA can donate to district after reviewing budget
- 3. Public Relations get word out about shortfall and need for donations
 - a. put on LWLA Facebook
 - → Carolee to update Facebook to communicate need for donation
 - b. Additional Lake Commission District Letter to go out prior to membership letter
 - → Kevin will draft letter & send to Terry to go out ASAP. Will explain have not had increase in fee attached to taxes in 10 years. Sean/Kurt will send to Staples for printing to include pictures so people know the difference between EWM and other weeds(S. Naiad)
 - → Patty to send out BJ Report so people know extent of problem
- 4. What about grants?
 - → Talk to O'Mara at Cuba NYSFLOA meeting in October.
- Does LWLA increase cost of events such as Pancake breakfast, make golf tournament selffunding, or increase cost of items LWLA sells. Currently LWLA does not make much of a profit on items.
- 6. LWLA unanimously agreed to recommend to district:
 - a. Increase fees attached to taxes
 - **b.** Draft letter to send out
 - c. Publicize need for donations
