August 20, 2016

Meeting called to order: 10:05 AM

Introductions: Welcome and thank you for coming. Not a lot of people here but let's get going.

Old Business:

- 1. Minutes from July 23, 2016 were approved unanimously as written.
- 2. Treasurer's Report: Kurt supplied a printed report with the following highlights:

- b. Sold \$983 worth of cloths but LWLA doesn't make much of a profit on clothes sales. We will not know what the profit is until after we take inventory.
- c. Kurt will get mailing lists from Dennis's weed treatment mailing to update the membership data base.
- d. Membership mailing needs more than \$.49 stamp if include magnet. Thought this would be an issue since envelopes already have postage but since decided not to include magnet this is no longer an issue. See mailing discussion/decision in Other Section below.

New Business:

- 1. Presidents Report
 - A. Pontoon Palooza

 - 1. Current level is 1097.9. Water evaporates 1.25 inches per week when no rain. Keuka lowest it has been in years.
 - G. Lake testing team
 - 1. Ron Dixon and Kurt went out on Lamoka and provided the testing results. Focusing on Temp and Oxygen for now. In September and spring will do PH.
 - 2. Ron Dixon will continue to do Lamoka and try to do Waneta if can get through channel. Various people on Waneta offered their boats. He also agreed to do next year.
 - 3. Kevin to order new zero oxygen to recalibrate device.
 - H. Weed treatment follow up
 - 1. Bob Johnson found a few small spots on Waneta and none on Lamoka. Mill pond is a mess. Will need to do some sort of treatment again next year.

- I. Pancake breakfast
 - 1. Thank you Ed & all his workers great job. Carolee was great as lead server and Cartha provided a lot of encouragement.
 - 2. Ed agreed to do again next year. Carolee will be lead server again.
 - 3. One complaint about eggs not being out fast enough. Will fix for next year.
 - 4. Received Thank You card from Bradford Food Panty for all the left overs.
- J. Steuben/Schuyler Watershed Committee no meeting since last so no report

3. OTHER:

- A. Mailing discussion/decision on who should get what mailing
 - 1. Weed treatment letter has to go to all no discussion/decision needed
 - 2. Send membership letter to all lake owners without magnet and newsletter with magnet just to paying LWLA members. This is a change from all lake owners getting both mailings.
 - Motion passed 6 yes and 2 no
 - People who voted yes felt that members should get something extra for their dues and if non-members wanted information they were welcome to pay their dues
 - People who voted no felt all lake owners should get both mailings. The thought
 was by giving them information in the newsletter that would educate them and
 would encourage them to become paying members. There was also a concern if
 we missed any paying members on newsletter mailing they may no longer pay
